Well 2015 is in the books. I hope everyone enjoyed a Merry Christmas and a Happy New Year. 2016, however, poses new challenges for our hobby as a result of late year registration rules promulgated by the FAA in direct contravention to Congressional the 2012 FAA Modernization and Reform Act section 336. This regulation specifically prohibits the FAA from promulgating regulations for recreational users operating within the safety guidelines of a CBO such as the AMA. In addition, the FAA's contention that model aircraft should be considered aircraft is currently the subject of pending litigation.

In this person's sole opinion the FAA is taking advantage of the security concerns precipitated by the rash of terrorist actions and plots currently affecting countries around the globe to provide a sense of urgency to promulgate "feel good" regulations that are in direct conflict with existing Congressional regulations. The FAA regulation will do little or nothing to prevent the use of all available technologies to inflict carnage and fear to non-Islamic terrorist cultures. And, as has been made abundantly clear by the media reports, the FAA is unable to enforce the existing air space regulations and penalties on those persons that unknowingly or knowingly violate those regulations.

Although the FAA sates that the one of the primary purposes of the registration process is to ensure that persons operating outside the organizations like the AMA know the rules, the levels of proposed fines far exceeds any "reasonableness" test. And even the FAA explicitly states there are no additional FAA resources to be employed nor did they attempt to quantify any "safety benefit" from the regulation. How can the FAA reconcile this position with their original determination that there are an increasing number of dangerous incidents occurring in the NAS?

EXACT TEXT from the FAA Interim Final Regulation

Safety

We assume this regulation does not affect the levels of FAA manpower or resources

expended on UAS safety education and outreach but it will allow the FAA to target those

efforts, making those on-going efforts more effective.

We do not attempt to quantify any safety benefit from this regulation. (See "Qualitative")

Benefits" section in the Regulatory Evaluation for further discussion).

In short it's just more big government intruding on Americans' personal freedoms with no tangible benefit.

The FAA and the American public would be much better served by the FAA cooperating with and supporting organizations like the AMA. The support would start with the FAA acknowledging that AMA and its members be exempt from the registration requirement. It would continue by giving non-AMA members the option to join an recognized organization like the AMA or registering on the FAA's website. This approach would be a win-win for everyone and greatly enhance the Science Technology Engineering and Math (STEM) initiatives the government and public sector are promoting to help American children develop an interest in and capability to compete in the technologies that will make America a global leader well into the future.

One concession the AMA would need to make (and has already offered to make) is to provide the FAA with the AMA membership ID numbers and address information. I believe that this would be a very reasonable compromise.

Although the Interim Final Regulation is in effect now, there is an open window for public comment until Jan 15th and a final registration deadline of Feb 19th. At the end of this article is the AMA's recent pro-action request to its members. In short the requests boil down to:

- a) Hold off on registration as long as possible pending the outcome of the public comment and AMA's efforts.
- b) Take advantage of the open public comment period thru Jan 15th to clearly and loudly register our voices with the FAA. The link is: <u>http://1.usa.gov/1Jegj0C</u>.

The outcome of our combined efforts could well make the difference between the continued enjoyment of our hobby unfettered by excessive and ineffective government regulation not only for us but for our children and children's children for generations to come.

In the end, however, your officers are charged with making sure that the BFMS and its members fully comply with all pertinent laws and regulations. But that does not mean we have no voice. This is AMERICA; home of the brave and land of the free.

Come on out to our January meeting and share your views and suggestions with the club officers and members.

Next Meeting at P.J. Whelihan's Pub at Platz's, 101 Harrity Road,

Located at the Mahoning interchange of the PA Turnpike just across the Pohopoco Creek from Route 209 The AMA has recommended that our members hold off on registering their model aircraft with the FAA until advised by the AMA or until the FAA's legal deadline of February 19. Holding off on registration will allow time for AMA to fully consider all possible legal and political options for alleviating this unnecessary regulatory burden on our members.

In the meantime, you can help by making your voice heard with the FAA. Specifically we are asking all AMA members to submit comments on the FAA's interim rule on registration. The deadline to submit comments is January 15, 2016. All comments can be submitted at <u>http://1.usa.gov/1Jegj0C</u>.

Below are recommended messages to convey in your comments:


- Express your disappointment with the registration rule. As a member of the Academy of Model Aeronautics (AMA), I am disappointed with the new rule for UAS registration. I am a long time model aircraft flyer, who has operated under the guidance of the largest community-based organization (CBO) in the world for many years.
- Highlight AMA's history and safety record. Since 1936, AMA has published safety standards and offered training programs for our members - more than 20 years before the FAA was created. Our National Model Aircraft Safety Code has been recognized by Congress as well as by state legislatures as a safe and effective means of managing model aircraft enthusiasts like me.
- Note that you already register with AMA. Additionally, AMA's safety program already instructs me to place my AMA number or name and address on or within my model aircraft(s), effectively accomplishing the safety and accountability objectives of the interim rule.
- Make it clear this rule is contrary to the intent of Congress. The new rule is contrary to the intent of Congress in Section 336 of the 2012 FAA Modernization and Reform Act. Section 336, also referred to as the "Special Rule for Model Aircraft," clearly prohibits the FAA from promulgating any new rules for recreational users operating within the safety guidelines of a CBO. In addition, the FAA's contention that model aircraft should be considered aircraft is currently the subject of pending litigation.
- Affirm that as an AMA member you should be exempt from federal registration. The registration process is an unnecessary burden for me and the more than 185,000 other AMA members. AMA members should not be required to register with the FAA.
